

## EXHIBITOR RULES AND REGULATIONS (cont.)

- C. Exhibitors desiring return of exhibits by mail must provide a sufficient allowance for registration and insurance return receipt requested, along with sufficient provision for return postage via priority or expedited mail. Use of parcel post is not recommended.

### VIII. INSURANCE, LIABILITY AND SECURITY

- A. Insurance of exhibits is the responsibility of exhibitors.  
B. All reasonable care will be taken to safeguard each exhibit, however, neither the MID-CITIES STAMP CLUB nor the GRAPEVINE CONVENTION CENTER, their officers, members, management, employees, agents or associated persons shall be liable for any damage to, or loss of any exhibition material arising from any cause or reason whatsoever.  
C. Security service will be provided from 9:00 pm Friday, November 11 to 8:00 am Saturday, November 12; and from 5:00 pm Saturday, November 12 to 9:00 am Sunday, November 13.

### IX. AWARDS

The best and second best multi-frame division exhibits will receive the Grand Award and the Reserve Grand Award respectively. Special awards will be awarded to the best exhibits in the display, one-frame and youth divisions. Gold, silver and bronze awards will be presented on an open show basis. A number of philatelic societies will be offering special awards, which may be subject to certain requirements limiting their availability. (Book Titled one-frame exhibits will additionally be judged for popularity by MCSC members. 1st place win a \$25 certificate to Half-Price Books.)

### X. JUDGING

- A. A jury panel of American Philatelic Society accredited judges will evaluate exhibits according to accepted standards of the American Philatelic Society. The panel will make decisions by deliberations and consultations among themselves.  
B. The criteria of the sponsoring groups will be considered when evaluating exhibits for special awards.  
C. Special criteria will be used to evaluate exhibits entered in the youth and one-frame divisions.  
D. No award shall be made if, in the opinion of the jury panel, a particular exhibit lacks sufficient merit.  
E. The decisions of the jury panel will be final and no appeals will be considered by the Mid-Cities Stamp Expo sponsors.

### XI. RULING AUTHORITY

Any and all questions not covered by these rules and regulations will be decided by the Exhibits Chairperson, whose decision is final.

### XII. ACCEPTANCE

An exhibitor's signature on the OFFICIAL ENTRY FORM signifies acceptance of these rules. (A separate entry form is available online for 1-4 page exhibits.)

## AWARDS

The MID-CITIES STAMP CLUB will present on an open show basis **GOLD, SILVER and BRONZE** awards. Additional awards, as detailed in the list that follows, will be available, but are subject to the restrictions of the societies offering them. The **TSDA** award will be presented at 3:00 pm on Sunday, November 13, 2011. All the others will be presented at an awards dinner at 7:30 pm on Saturday, November 12, 2011. Tickets are required for the banquet.

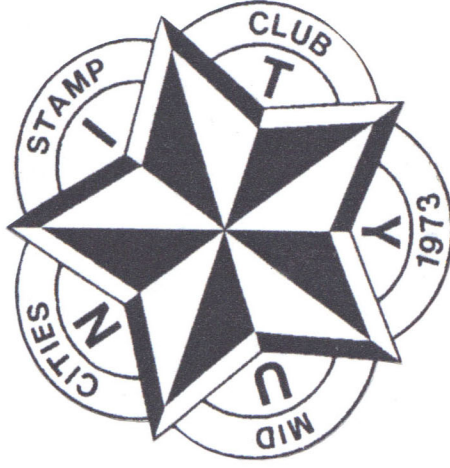

# EXHIBITOR RULES AND REGULATIONS

## I. ELIGIBILITY

- A. Exhibiting in the Mid-Cities Stamp Expo is open to all collectors regardless of club affiliation or residence. However, exhibits having previously won a Grand Award in this show are ineligible to compete for Grand Award in subsequent shows.  
 B. Each exhibit must be the bona fide property of the exhibitor and may not contain any material, which is to be offered for resale by a philatelic dealer. All work contained within the exhibit shall represent the owner's efforts.

- C. Any counterfeit and/or bogus material must be clearly identified as such.  
 D. Anonymous exhibits will be accepted. Other exhibitors will be listed by name.

## II. CLASSIFICATIONS

- A. Exhibits shall be divided into multi-frame, display/illustrated mail, one-frame and youth divisions. Exhibits shall be further divided into classifications primarily for the convenience of setup and viewing by the public. Classification shall not affect the criteria used in evaluation exhibits for general awards.  
 B. Exhibitors may enter in as many classifications as is desired, subject to the frame limits indicated in Rule IV.E., but a separate entry form is required for each exhibit.  
 C. The jury panel or Exhibits Chairman may reclassify exhibits that, in their opinion, are not entered in the proper class.

## III. ENTRY

- A. Applications for entry must be made on the **OFFICIAL ENTRY FORM** or facsimile with the appropriate **ENTRY FEES PAID** at the time of application. A clear photocopy of the first page of the exhibit should also be enclosed or, if not yet available, be sent separately by October 9, 2011.  
 B. Entries will be accepted until October 17, 2011. Entries received thereafter may be accepted on a space-available basis.  
 C. Notice of acceptance will be sent to exhibitors. No exhibits are to be forwarded until such notice has been received.  
 D. The Exhibits Chairman reserves the right to reject any entry before the opening of the exhibition and to return the entry form together with related fees.  
 E. Failure to exhibit after notification of acceptance will result in forfeiture of all entry fees.  
 F. Non-competitive exhibits may be accepted only by invitation.

## IV. FRAMES AND PAGES

- A. Each frame is designed to accommodate 16 pages of 11" height by 8 1/2" width or 12 pages of 11" height and up to 11" width.  
 B. Modular or oversize poster displays (up to the frame dimensions), may be accepted from exhibitors who have made an arrangement in advance with the Exhibits Chairman and who deliver such entries in person or by an agent.  
 C. Each page of an exhibit shall:  
 1. be numbered consecutively on the back  
 2. bear the exhibitor's name on the back  
 D. Enclosure of exhibit pages in transparent sheet protectors is strongly recommended.  
 E. Each exhibitor is limited to a total of 10 frames for all exhibits entered.

## V. FEES

- A. Entry fees are \$6.00 per frame for the multi-frame, display and one-frame divisions and \$3.00 per frame (first two frames are free) for the youth division (18 years of age or younger).  
 B. All fees (payable to: Mid-Cities Stamp Club) must be submitted with the application for entry to: **Mid-Cities Stamp Club, c/o Ray E. Cartier, 2509 Buffalo Drive, Arlington, TX 76013.**

## VI. DELIVERY OF EXHIBITS

- A. Exhibitors shall assume all responsibility for getting their exhibits to the exhibition hall, whether by personal delivery or by mail.  
 B. Personally delivered exhibits will be mounted by the owner or his designated agent at the Grapevine Convention Center on Friday, November 11, 2011 between 6:30 pm and 8 PM or on Saturday, November 12, 2011 between 8 am and 9:30 am.

- C. Mailed exhibits should arrive no later than November 9, 2011 nor earlier than October 31, 2011, and must be sent insured and/or registered via the United States Postal Service to: **Mid-Cities Stamp Club, c/o Ray E. Cartier, 2509 Buffalo Drive, Arlington, TX 76013.**

## VII. REMOVAL OF EXHIBITS

- A. No exhibit, nor any part thereof, shall be removed from the exhibition hall prior to the closing of the show at 4:00 pm on November 13, 2011.  
 B. Exhibitors desiring to remove their material in person or through an agent must provide authorization on the entry form. The exhibitor or his agent may then remove the exhibit only upon providing proof of identity and signing a release form.
